Companies Holding an Exporter-Importer Registration Certificate to Update Company Particulars Filed with the Ministry of Commerce by 3 September 2019

The Ministry of Commerce (“**MOC**”) issued Newsletter No.4/2019 (the “**Newsletter**”) on 3 July 2019 reminding all companies holding an Exporter-Importer Registration Certificate to update their company particulars filed with the MOC following the completion of the re-registration process on the MyCO registry (i.e. under the Myanmar Companies Law 2017) by 3 September 2019. According to the Newsletter, a failure by a company to update its company particulars by the stipulated deadline could result in the cancellation of the company’s Exporter-Importer Registration Certificate by the MOC.

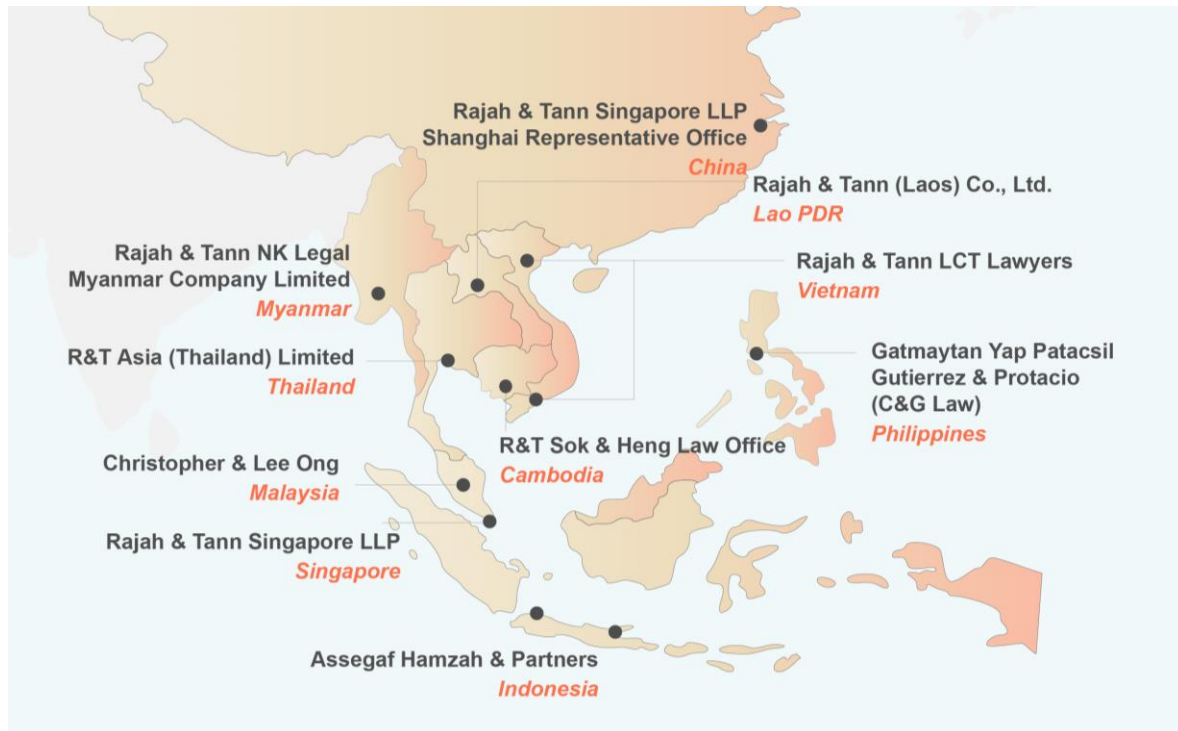
